A RESOLUTION SUPPORTING THE EXTENSION OF INTERSTATE 27 ALONG THE PORTS-TO-PLAINS CORRIDOR SOUTH OF LUBBOCK.

WHEREAS, Congress has already designated the Ports-to-Plains Corridor in Texas as a High Priority Corridor on the National Highway System; and

WHEREAS, the Texas Department of Transportation published an *Initial Assessment Report on the Extension of I-27/Ports to Plains Corridor* in November , 2015 which stated: “The corridor will continue to be a critical link to state, national and international trade, growing population centers and critical energy and agricultural business sectors”; and

WHEREAS, the *Texas Freight Mobility Plan* notes that further investment alone on I-35 will not fix the problem saying, “The state must focus not only on improving existing facilities, but also on developing future freight corridors to move products to markets and exports”; and

WHEREAS, the *Texas Freight Mobility Plan* goes on to recommend that TxDOT, “give additional consideration to the extension or designation of other interstate routes. Examples include I-27 and upgrades to portions of US Highway 190 to interstate standards”; and

WHEREAS, the proposed extension of Interstate 27 connects major West Texas population and economic centers including Amarillo, Lubbock, Midland-Odessa and San Angelo in addition to numerous smaller communities; and

WHEREAS, the proposed extension of Interstate 27 intersects with Interstate 40, Interstate 20 and Interstate 10; and

WHEREAS, the proposed extension of Interstate 27 will serve three border crossings with Mexico at Del Rio, Eagle Pass and Laredo; and

WHEREAS, the proposed extension of Interstate 27 will be a major backbone for the energy industry in Texas serving top oil and gas producing counties as well as the growing wind energy industry; and

WHEREAS, the proposed extension of Interstate 27 will also serve the agriculture industry including many of Texas top counties for the production of cotton, cattle, sheep and goats and other commodities; and

WHEREAS, extending Interstate 27 in Texas is also a cost-effective option. The Texas Department of Transportation’s *Initial Assessment Report on the Extension of I-27/Ports to Plains Corridor* estimated that it would cost about \$7 billion to upgrade the nearly 1,000 miles of the Ports-to-Plains Corridor from the northern tip of Texas to Laredo. To extend Interstate-27 approximately 500 miles from Lubbock to Laredo is projected to cost \$5.2 billion. Compare that to the \$4.8 billion it cost to rebuild 28 mile section of Interstate 35 east from Interstate 635 to U.S. Highway 380 in Dallas County; and

WHEREAS, an additional cost saving option is associated with the primarily east-west, recently designated, Interstate 14 which includes a proposed segment that overlaps the Ports-to-Plains Corridor between Midland-Odessa and San Angelo, presenting an opportunity for that segment to be jointly designated as Interstate 14 and Interstate 27; and

WHEREAS, a future Interstate designation will be a significant new economic development tool for communities along the corridor. Site selectors for manufacturers, warehousing and distribution recommend sites along an interstate highway and travel services businesses such as hotels, truck stops, convenience stores and restaurants, which can have a dramatic impact on small communities will also expand. This will create much needed new jobs and expanded tax base in rural West Texas; and

WHEREAS, while designation as a future interstate is the first step in a very long process before the completion of an interstate highway, that does not lessen the importance of extending Interstate 27.

NOW THEREFORE, BE IT RESOLVED BY THE VAL VERDE COMMISSIONER'S COURT OF VAL VERDE COUNTY, TEXAS

Section 1. That the VAL VERDE COMMISSIONER'S COURT supports the extension of Interstate 27

Section 2. This resolution to be in full force and effect from and after its passage and approval.

Section 3. If any portion or provision of this resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such portion or provision shall not affect any of the remaining provisions of this Resolution, the intention being that the same are severable.

THE CASE FOR EXTENDING INTERSTATE 27



PORTS-TO-PLAINS ALLIANCE



When the Ports-to-Plains Corridor Coalition originated in the mid-1990's it envisioned extending Interstate 27 to serve as a major corridor for NAFTA trade. Conditions at the time did not warrant expansion to interstate standards, and the coalition has worked to upgrade the corridor to four-lane divided with truck relief routes where needed. Those efforts have led to more than \$1 billion in upgrades to the corridor. NAFTA trade and freight has grown dramatically and congestion in Texas' metropolitan areas has continued to increase. Considering the long-term proposal of upgrading the Ports-to-Plains Corridor in Texas to interstate standards, it is imperative to designate an extension of Interstate 27 to Laredo from its current end point in Lubbock.

Although completely upgrading the Ports-to-Plains Corridor to four-lane divided highway will be very beneficial, a full upgrade to interstate standards is important. According to the Texas Freight Mobility Plan, "By 2040 over 73 percent of Texas' population and 82 percent of the state's employment is projected to be located within five miles of an interstate." An extended Interstate 27 is critical for the economic competitiveness of West Texas.

Texas does not have a major North-South interstate west of Interstate 35. Where Interstate 69 can serve as an alternative for freight moving to the northeast, an extended I-27 can be an I-35 relief route to the northwest.

Undoubtedly NAFTA and increased trade with Mexico have had a tremendous impact on freight movement through Texas. Data published by the Bureau of Transportation Statistics show that the value of U.S. - Mexico trade and Texas-Mexico trade increased by 99.2% and 90.9% respectively between 2004 and 2015. That report showed that in 2015 U.S.-Mexico trade amounted to almost \$513 billion. The office of the U.S. Trade Representative reports that in 2015 U.S. goods and services trade with Mexico totaled \$583.6 billion. The Bureau of Transportation Statistics reported in 2015 that on average more than 85.7% of US-Mexico trade is transported by surface modes, and trucks move 82.8% of the value of U.S.-Mexico surface trade. Furthermore approximately 60% of U.S.-Mexico trade crossed at a Texas land port in 2015, with Laredo being far and away the largest land port and Eagle Pass ranked third in Texas.

Same 2,000 Trucks After 7 Days




Much of that freight moves up I-35 and has led to a tremendous increase in congestion. The Interstate 35 segment through Travis County is the number 1 ranked corridor for truck congestion in the state. This truck congestion has a detrimental impact on the communities through which it passes.

Many of the counties through which I-35 passes experience higher frequencies of fatal and total crashes related to commercial motor vehicles than other counties. Several cities within the large metro regions served by the I-35 corridor do not currently abide with TCEQ and EPA 8-hour ozone standards.

The Texas Freight Mobility Plan notes that further investment alone on I-35 will not fix the problem. The Plan says, "The state must focus not only on improving existing facilities, but also on developing future freight corridors to move products to markets and exports." It goes on to recommend that TxDOT, "give additional consideration to the extension or designation of other interstate routes. Examples include I-27 and upgrades to portions of U.S. 1-90 to interstate standards."

Construction did not begin until 1975 and was completed in 1992 at a cost of \$453 million, at a time that transportation funding was much more adequate to meet demands. Extending I-27 approximately 500 miles from Lubbock to Laredo will certainly take much more time and money. That is why it is so important to take that first step now and designate an extension of Interstate 27 to Laredo. The state has significant demands for a very limited transportation budget, but that does not lessen the importance of extending Interstate 27.

VAL VERDE COUNTY FAIRGROUNDS LEASE AGREEMENT

This Agreement is entered into by and between the County of Val Verde ("Lessor"), acting herein by and through its County Judge as authorized agent for Lessor and **George Paul Memorial Bull Riding** ("Lessee") acting by and through its agent, Bobby Paul, for the lease of premises more commonly known as the Val Verde County Fairgrounds. For and in consideration of the mutual promises hereinafter set out to be kept and performed, the parties hereby agree to the following terms and conditions:

1. Terms of Lease: This lease shall commence on 02/01/2017 and end on 05/01/2017 for use of the office located at the Val Verde County Fairgrounds. For all other uses, this lease shall commence on 04/14/2017 at 7:00 a.m. and end on 05/01/2017 at 7:00 p.m. This includes the delivery and retrieval of Lessee's equipment, livestock, etc. by Lessee to and from the Val Verde County Fairgrounds. The event days are as follows: April 28th and April 29th, 2017.
2. Description of Property: This lease includes the office beginning on 02/01/2017 and ending on 05/01/2017. The following building(s) and area(s) located on the Val Verde County Fairgrounds are to be leased beginning 02/01/2017 and ending 05/01/2017.

*There will be no glass bottles permitted at the concessions stands.

3. Consideration: Lessee shall pay to the County of Val Verde as consideration for the use of the fairgrounds, the amount of \$1,000 per event day, payable when the contract is executed. Lessee shall pay to the County of Val Verde as consideration for the use of the fairgrounds office, the amount of \$200 monthly, payable when the contract is executed. In addition, a deposit in the amount of \$500 shall be paid at the time and in accordance with the terms specified in paragraph 9 of this lease agreement. No other fees or payments are authorized unless specifically set out in the Lease Agreement.
4. Cancellation: The following amount will be refunded if Lessee seeks to cancel this Lease Agreement. This notice of cancellation must be made in writing and delivered to the Val Verde County Judge.

If notice is received 45 days or more prior to event - 100% refund
If notice is received 45 days to 20 days prior to event - 50% refund
If notice is received less than 20 days prior to event - 0% refund

5. Deposit Refund: The deposit paid by Lessee shall be refunded to Lessee by Lessor within 10 days after Lessee and Lessor's agent inspected the property and determined that it is unacceptable condition an after Lessor's agent has determined that all costs of utilities (or clean up fees as specified in paragraph 9 of this lease) have been paid. Appropriate amounts shall be deducted for damages to the premises, as well as for nonpayment of utilities. These deductions shall be specified in writing and delivered to Lessee on or before the date the deposit refund is due.
6. Inspection of Property: Lessee shall inspect the property prior to the execution of this Lease Agreement to determine if the property is acceptable and suited for its intended use. By executing this Lease Agreement, Lessee acknowledges that the property has been inspected and is suitable for its intended use in its current condition.
7. Equipment: Lessor shall not provide any equipment to Lessee. Lessor shall prepare the arena for use by Lessee on 04/27/2017. This does not include set up for event. Lessee shall inspect the arena to determine if it is satisfactory for its intended use. Thereafter, it shall be the Lessee's sole responsibility to maintain the arena for its intended use during the lease term.
8. Utilities: Lessee shall be solely responsible for the payment of utilities (water/electricity) during the lease term.
9. Clean-up: Lessee and Lessor acknowledge that Lessee has the option to clean up the facilities.

In the event Lessor is responsible for clean-up, Lessee shall deliver to Lessor a \$500 deposit/clean up fee along with written confirmation that he is exercising the option of having Lessor clean up the premises. Lessor warrants that there will be a cleanup crew after every performance and that clean up shall be accomplished prior to each performance.

In the event Lessee is responsible for clean up, Lessee shall deliver to Lessor a \$500 deposit along with written confirmation that he is exercising the option of cleaning up the premises. Lessor shall inspect the premises on a date as specified in opportunity to correct any clean up problems as indicated by Lessor or Lessor's agent prior to the expiration of the lease term.



12. **INDEMNIFICATION: LESSEE SHALL AND DOES HEREBY FULLY INDEMNIFY AND HOLD HARMLESS THE COUNTY, ITS SUCCESSORS, ASSIGNS, AGENTS, REPRESENTATIVES, CONTRACTORS AND EMPLOYEES FROM AND AGAINST ANY AND ALL LIABILITIES, INJURY, DEMANDS, SUITS, ACTIONS, CLAIMS, PROCEEDINGS, DAMAGES, JUDGMENTS, AWARDS, PENALTIES, COSTS AND/OR EXPENSES, INCLUDING BUT NOT LIMITED TO REASONABLE ATTORNEYS FEES, OF WHATSOEVER NATURE, PAST, PRESENT OR FUTURE, ARISING FROM OR RELATED TO PERFORMANCE OF THIS AGREEMENT.**
13. Rules and Regulations: Lessee shall at all times adhere to the Rules and Regulations adopted by the Val Verde County Fairgrounds Committee. By signing this Lease Agreement, Lessee acknowledges that a copy of the Rules and Regulations has been provided to Lessee and that Lessee has read and understands said Rules and Regulations. A copy of said Rules and Regulations is attached to this agreement as Exhibit "A" and Exhibit "B."
14. Resolution of Problems: The Fairgrounds Manager shall be available for resolution of any problems which may arise during the lease term, which includes problems arising during the event. In the event no resolution is reached, Lessee may request assistance from the Val Verde County Commissioners Court designee. Lessor warrants that the Fairgrounds Manager or another person designated by the Val Verde County Commissioners Court shall be available to Lessee during the event.
15. Violation of Lease Agreement: If Lessee violates any of the terms of this Lease Agreement, including the Rules and Regulations, the County of Val Verde shall give written notice of the violation and the Lease Agreement

shall become immediately void. Any monies paid as consideration for this Lease Agreement shall be forfeited.

16. Parties Bound: This Lease Agreement shall be binding upon and inure to the benefit of the parties and their respective heirs, executors, administrators, legal representatives, successors, and assigns where permitted by this Lease Agreement.
17. Applicable Law: This Lease Agreement shall be construed under and in accordance with the laws of the State of Texas, and all obligations of the parties are performable in Val Verde County, Texas.
18. Healthy County 2016 Employer Rewards

The mission of Healthy County, the Texas Association of Counties Health and Employee Benefits Pool wellness program, is to optimize the health and well-being of its members.

What is the Healthy County Employer Rewards program?

A successful wellness program requires effort and support at the local level. The Healthy County Employer Rewards program honors participating members for their efforts and success in helping employees enroll and complete various Healthy County programs. The Texas Association of Counties Health and Employee Benefits Pool grants eligible employers funds based on the amount their employees earn in incentive prizes through program participation. A member county may use the Pool's funds for future health and wellness initiatives.

Who is eligible to receive employer rewards?

An Employer is eligible to receive a reward if they:

- Are a member of the Pool (ASO groups are not eligible);
- Designate a wellness coordinator and wellness sponsor

How do members earn employer rewards?

Members earn rewards based on their employees' participation in Healthy County activities. In 2016, employees were eligible to receive a \$60 gift card for completing the requirements of the 100-Day Sonic Boom Challenge AND an online health assessment.

Counties will earn a percentage of the maximum allowed amount (see table below) based on the number of employees who earned the \$60 incentive. The maximum amount will be based on the number of covered employees.

Group Size	Max Amount Available to Earn
Under 50 Lives	\$3,000
50-99 Lives	\$5,000
100-199 Lives	\$7,000
Over 200 Lives	\$9,000

Example: County A has 100 employees. 28% of their employees earn the \$60 incentive. The county will earn \$1,960 (28% of \$7,000) in Employer Rewards for 2016 participation.

Why is the Pool doing this?

The Pool's intention is to provide members with resources to build a positive, healthy and safe work environment and to encourage employees to engage in healthier behaviors.

The Pool's members, including elected officials and employees of Texas counties, represent one of our state's most valuable assets - public servants to all Texas citizens. When officials and employees are healthy, they are better able to provide quality service, manage stress appropriately, experience fewer lost workdays and model healthy behaviors for their families and the community. Healthy employees also save taxpayers' money due to lower health care costs and workers' compensation costs, as well as a reduced rate of absenteeism. The Pool's ultimate goals are to reduce health care costs and make better use of taxpayers' dollars by improving the quality of your employees' health.

How can a member use the Healthy County employer rewards?

The Pool recommends reward funds be applied toward the member's wellness program and:

- be health related;
- be available to all employees; and
- promote ongoing attention to health initiatives that provide lasting benefits.

Ideas for how to use Employer Rewards

- **To provide healthy evidence-based worksite and safety programs.** Trainings can arm individuals with new knowledge about their own health and safety. Examples include: flu, pneumonia and adult vaccinations; biometric screening for cholesterol, triglycerides, blood glucose and blood pressure; learning lunches or educational programs (like those provided by Agrilife Extension Agents such as Do 'Be Well with Diabetes and Step Up & Scale Down) and ergonomic training.
- **To support the people who are responsible for coordinating county health initiatives, building infrastructure and promoting employee wellness.** Health initiatives are more effective when the person assigned to promote the program is provided with time and resources necessary to meet identified objectives.

Healthy County 2016 Employer Rewards

Examples include: county officials allowing time and budgeting financial resources for the Healthy County wellness coordinator to roll out programs and organize wellness initiatives.

- **To prepare and implement safety, health and wellness policies.** Policies that reinforce healthy lifestyle efforts encourage a healthy worksite culture.

Examples include: smoke free policies, clean-air maintenance plan; allowing a flextime schedule to encourage exercise during lunch; and creating a media library for employees to check-out educational DVDs on various health and safety topics such as stress management, the risks of obesity, balancing work and home life, co-worker dynamics, and the importance of physical exercise, etc.

- **To improve environmental working conditions.** Health and productivity are increased by identifying ways to improve the employees' physical work environment and implementing changes.

Examples include: installing hands-free fixtures (faucets, flushers, soap and paper towel dispensers) in restrooms and kitchens to slow down the spread of infections; purchasing a kiosk computer to provide Internet access for those without a work or home computer; conducting a worksite wellness audit; developing walking routes and trails near the worksite; installing bike racks or creating a bike storage area; installing slip-resistant flooring and guardrails; providing shower and changing facilities; setting up motivational signs; and adding rubber treading to stairs or carpet to encourage stair climbing at the worksite.

- **To improve the nutritional value of food products available to elected officials and county employees.** Healthier food choices during the work day equal healthier adults.

Examples include: purchasing (or subsidizing) a healthy snack machine with items such as fat-free milk, fruits, low-calorie snacks and caffeine-free beverages; and hosting a Farmer's Market during peak growing seasons.

- **To encourage participation and sustain employee engagement in health and wellness activities.** The purchase of incentives is permitted, subject to restrictions in state and federal law.

Health Insurance Portability and Accountability Act (HIPAA) Wellness Program Rules:

- Classify wellness programs as either participatory or health-contingent, with different rules for each;
- Classify health-contingent wellness programs as either activity-based or outcome-based, with different rules for each; and
- Set out five requirements for health-contingent wellness programs:
 - Includes annual opportunity to qualify for reward;
 - Sets limits on amount of award based on cost of employee-only coverage;
 - Requires program be reasonably designed to promote health or prevent disease;
 - Requires program include a reasonable alternative method for earning a reward be provided for employees who are otherwise unable to meet the requirements to earn an award; and
 - Calls for notice of availability of reasonable alternative in all program materials.
