City is seeking to obtain sealed bids from qualified vendors who can provide the City **repairs to the roof of the airport terminal building**. The current roof has been in place since 2010 and requires to be repaired to correct leaks and surface blistering.

A Pre-Bid Meeting will take place at the City of Del Rio International Airport located at 1104 W 10th St, Del Rio, TX 78840 for any vendor who is interested in visiting the locations prior to submitting the bid on **April 18, 2023 at 1:00 PM**. The City will be accepting sealed bids up until **2:00 PM on May 5th, 2023**. Bids can be mailed, or hand delivered to the City of Del Rio City Hall.
